Use findings to engage farmers directly, and to create steering group(s) of facilitators for longer term engagement. A September event to share learnings from Climathons with CLG is in development. Expand farmer clusters across county to help enable: Utilisation of Climathons consistently to consult meaningfully with rural stakeholders Go further to explore development of a Land Use Framework Enhance peer-to-peer farmer learning, knowledge sharing, and farmer-led projects as per CDC and FoD Climathon outcomes. Work to develop the innovative ideas and pathfinder projects that arise from rural stakeholder engagement – liaising with the county's academic institutions and farmer representative bodies, and incorporating into climate strategies. Work with partners to present these solutions to farmers and encourage their adoption. Identify and work with the F&F Partnership and other local partners such as the National Farmers Union to promote the county as a pioneering area for agritech and decarbonisation. Work with partners such as the Feeding Gloucestershire initiative and food hubs to develop methods to minimise waste and better utilise food. Assess the potential of CLG partners to directly act-such as adoption of dynamic procurement systems that shorten supply chains. This should include assessment of the climate impacts of these actions.	Theme lead, CLG	Late 24	This is a medium term goal-if/when further resources become available to progress. Theme lead Cotswold DC have created and appointed a food sustainability officer in recognition that improving and delivering food sustainability is critical. Feeding Gloucester and Cotswold District Council are developing a district-wide Cotswold Food Network, to which the Council is committing £40,000 from 2024 to 2026 to improve food sustainability in the district. Other sustainable food initiatives will be identified across the county and alignment explored via the project detailed under 0601.
