1.0 Welcome and apologies

A minutes silence was held in memory of Cllrs Theodoulou and Awford who both passed recently.

3.0 April Cycling Forum

To date, 4 people have submitted an application to represent the Cycling Forum on CAG. These will be anonymised and shared with Forum attendees so that they can vote for representatives at the April forum.

Cheltenham & Tewkesbury Cycle Campaign (C&TCC) requested a place on CAG by right. The unique perspective of some members of the C&TCC was recognised but the group but it was felt that anyone representing the forum must be held to the same standard or democratic election as any other representatives from the forum.

PW clarified that C&TCC want to be involved with formative discussions.

SW advised that CAG do not have these discussions and are probably not the right group as they are not a decision making body.

Discussion was held on the lack on underrepresented groups at the forum.

CC advised contact with Bex Mountford, a vocal and recognised advocate of cycling.

4.0 Funding opportunities update

GCC have submitted a bid to Active Travel Fund 4, which focuses on the cycle spine. An announcement is expected next week.

Officers continue to seek other funding opportunities to progress Mini Holland and Local Cycling and Walking Infrastructure Plans.

The impending budget announcement is rumoured to likely cut active travel spending. In a statement written by secretary of state for transport Mark Harper last week, it was announced that £100M would be spent on active travel in the next two years. With £230M already having been spent so far, the amount for active travel has more than halved from the Spending Review in 2021, which set out the £710M spending plans.

GCC have submitted a bid to National highways designated funds for new and improved infrastructure between Shurdington-Brockworth-Gloucester via the A46 and Abbeymead/Metz Way.

Cotswold District Council have announced a mechanism to bid into their CIL contributions. District Cllr Trotter will be bidding for funding to progress the Lechlade-Fairford corridor. GCC will bid to progress the Kemble-Cirencester corridor.

PW and DW advised that Cheltenham now have a CIL bidding process. *Post meeting note:* The Cheltenham CIL bidding opportunity is for Parish Councils, not large strategic schemes.

DW requested discussions regarding Rowanfield School ambitions to improve active travel.

B4063 Gloucester to Cheltenham Cycle Scheme	Design - Junction modelling has been undertaken on Estcourt Road Roundabout, which has informed the design. The preferred option is currently a Dutch Style Roundabout. Consultation - Consultation between Elmbridge Court and Oxstalls Lane has been completed and GCC will share the feedback on the project website soon. - Consultation will be planned for Estcourt Road Roundabout once the concept proposals have been finalised. Construction - Elmbridge Court Roundabout to Golf Course Access is currently under construction. - Construction between Elmbridge Court and Oxstalls Lane will start later this year.
Gloucester Cycle Spine	Preliminary design is currently underway with consultation expected later this year ahead of delivery commencing at the end of 2023/24
Cheltenham to Bishops Cleeve Cycle Improvements	Preliminary design is currently underway with consultation expected later this year ahead of delivery commencing at the end of 2023/24
Cheltenham Mini Hollands Scheme	A DfT Active Travel Fund bid was submitted to progress design work. Officers continue to seek funding opportunities.
West Cheltenham Walking and Cycling Improvements	A DfT Active Travel Fund bid was submitted to progress the Quiet Ways proposal on Queen's Road/Gloucester Road, Shelburne Road and between Gloucester Road and P.E Way.
A419 Highway Improvements	Speed limit reduction has been advertised and will be installed on Horsetrough Roundabout this Spring/Summer.
