
## Places are limited so book now to avoid disappointment

In order to prepare the Minerals & Waste Development Framework (MWDF) information needs to be carefully reviewed and considered.



The collation of relevant information is known as the evidence base and is available as an on-line library which includes technical reports and background papers that inform the MWDF.
