The course provides knowledge and skills for supporting people with dementia. The topics include the changing brain, person centred language and communication approaches.

Dementia Link Worker (DLW) Award & Dementia Lead Award (DL) **Course Length – 11 weeks - one day a week**

Whether you are seeking to gain the DLW or the DL award, you will complete the same 11 workshops. For both awards, the focus is on being able to apply theory to practice in the workplace and support your colleagues to use person centred language & approaches when supporting people with a dementia and their carer's.

DLW Award – You will be asked to evidence ways you have used knowledge and skills from the workshops back into your area of practice to achieve this award.

DL Award – You will be asked to develop an action plan which will improve the lives of people with dementia and/or the people who support them within your organisation. Therefore, you will need to be in a position of leadership within your organisation such as a clinical lead, manager, commissioner etc.

For both DLW & DL – completion of Tier 1 is essential.

Please note you will be required to attend at least 2 CPD events in each 12-month period to maintain your award.

Train the Trainer (for DLWs & DL's) – 2 ½ days course

This is only offered to those who have achieved the DL or DLW Award. It will develop your confidence and ability to deliver *Understanding Dementia* awareness training within your organisation. The first 2 days will be in-person workshops to develop the skills as a trainer. The last half day will be in person with a member of the DET at your place of work to ensure that the resources you are provided with are appropriate for your area of service delivery. You will then be asked to deliver *Understanding Dementia* in your workplace which will be observed by a member of the DET. Please note there is an on-going re-validation process.
