Statement of Representations Procedure and Availability of Documents

The purpose of this statement is to demonstrate accordance with Regulation 19 of the Town and Country Planning (Local Planning) (England) Regulations 2012.

Title of the local development plan document under consideration:

Minerals Local Plan for Gloucestershire Publication Plan (2018-2032)

The subject matter and areas covered:

The County Council has published a Minerals Local Plan for Gloucestershire (2018-2032) and all 'specific' and 'general' consultation bodies have been notified as identified in the adopted Gloucestershire Statement of Community Involvement (SCI)¹. All other parties and individuals contained on the County Council's planning consultation database have also been notified. Those present on the planning consultation database have previously made comments on earlier consultation activities and / or have expressed an interest to be notified of future planning policy-related consultations undertaken by the Council – including the preparation of the minerals local plan.

The Minerals Local Plan for Gloucestershire Publication Plan (2018-2032) will provide a planning policy framework for minerals development throughout the county over a 15-year period between 2018 and 2032. It comprises of a long term vision for Gloucestershire in the context of minerals planning; a suite of strategic objectives; a mineral planning strategy; allocations for future aggregate working with individual detailed development requirements, and policies to support: - secondary & recycled aggregates, mineral safeguarding, the supply of minerals, the function of those allocations for future aggregate working, mineral restoration and development management matters.

Once adopted, the Minerals Local Plan for Gloucestershire (2018-2032) will replace in its entirety, the existing adopted minerals local plan, which has been in use since 2003. Its primary function will be to guide decisions on planning applications for minerals development over the plan period.

Period of invitation to make representations:

The adopted Gloucestershire Statement of Community Involvement (SCI) commits the County Council to undertake consultation on plan-making matters for a period of at

least six weeks, alongside Regulation 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012. As a consequence the Minerals Local Plan for Gloucestershire (2018-2032) and supporting documents will be available to view and comment upon from **Thursday 31st May 2018 through to 5pm on Friday 13th July 2018**. All representations need to be submitted by this date to meet with Regulation 20 (2) of the Town and Country Planning (Local Planning) (England) Regulations 2012.
