

Numbers of business engagements are recorded as outputs and outcomes via the Growth Hubs with the Net Zero service recording outreach, diagnostic meetings and carbon audits	GCC, Growth Hub Network, CLG	Ongoing	Confirmed funding for the programme for 25/26, providing the same resource as in 24/25. The programme will continue to provide countywide support through advice, guidance and events. Further work conducted to integrate the service into district council offers. Carbon auditing events progressing in Tewkesbury and Forest of Dean.	
0403	Theme 4: Economy	Net Zero Business Support Programme An enhanced longer term programme that provides greater benefit to the county's businesses and aids transition to net zero.	Provide an enhanced offer with additional specialist advisor support, sector specific activity, additional workshops, events, peer to peer learning and networking opportunities. Provide an associated grant scheme with circa £320,000 pot which could be spent on capital items between £3,000 and £25,000 per business with a requirement for administrative support. Additional costs of this enhanced offer have not been secured and therefore theme leads will consider further business support mechanisms to replace in action plan over 25/26.
